This quarter, 72% of REC clients had jobs, and 90% were living in independent housing. Over 90% of clients remained off drugs and alcohol and had no parole violations. The detailed data is below:

B. NARRATIVE REPORT

III. PROGRESS TOWARD GOALS

This is the second quarter of the third year of the Reentry Enhancement Coordination Program in Multnomah County. The Program served a total of 27 new clients this quarter. We had 11 clients successfully complete the program, 9 failed the program, and 40 continue to be engaged in the program. Participants transitioning into independent housing have increased this quarter from 75% to 90%. Overall, REC clients who are in the program have remained violation free at rate of 92% and alcohol and drug free at a rate of 91%. This is better than last quarter and continues to exceed the goal.

This quarter we held three graduation ceremonies awarding 11 clients certificates of completion. Graduation ceremonies were held on the dates listed below. All current program participants are required to attend the graduation. Many of the graduating clients shared their stories with current program clients. Having completed the REC Program these clients will continue in aftercare and transfer to an appropriate caseload based on risk score, crime type and geography.
